We represent Advance Stores Company, Inc. (“Advance Auto Parts”) located at 4200 Six Forks Road, Suite 2000, Raleigh, NC 27609. This notice will be supplemented with any new significant facts learned subsequent to its submission. By providing this notice, Advance Auto Parts does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

Nature of the Data Event

On May 23, 2024, Advance Auto Parts learned that, like many other companies, an unauthorized third party gained access to certain information maintained by Advance Auto Parts within Snowflake, its cloud storage and data warehousing vendor. Advance Auto Parts began an investigation to determine the nature and scope of the incident with the support of third-party experts and took measures to contain the incident and terminate the unauthorized access. The investigation determined that an unauthorized third party accessed or copied certain information maintained by Advance Auto Parts from April 14, 2024 to May 24, 2024. Advance Auto Parts conducted a detailed review and analysis of the affected information to determine the types of information contained therein and to whom the information relates. This review was completed on June 10, 2024.

This personal information that could have been subject to unauthorized access includes name, Social Security number, and driver’s license or other government issued identification number.

Notice to Maine Residents

On or about July 10, 2024, Advance Auto Parts began providing written notice of this incident to approximately thirteen thousand eight hundred fifty-eight (13,858) Maine residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon discovering the event, Advance Auto Parts moved quickly to investigate and respond to the incident, assess the security of Advance Auto Parts systems, and identify potentially affected individuals. Further, Advance Auto Parts notified federal law enforcement regarding the event. Advance Auto Parts is also working to further harden its systems. Advance Auto Parts is providing access to credit monitoring and identification theft protection services for twelve (12) months, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Advance Auto Parts is providing impacted individuals with guidance on how to better protect against identity theft and fraud. Advance Auto Parts is providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Advance Auto Parts is providing written notice of this incident to relevant state regulators, as necessary, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion.

NOTICE OF [Extra1 - Variable Heading]

Dear Sample A. Sample:

Advance Stores Company, Incorporated (“Advance Auto Parts”) writes to inform you of an incident that involves your personal information. This notice provides information about the incident, our response, and resources available to help protect your information from possible misuse, should you feel it appropriate to do so.

What Happened. On May 23, 2024, we learned that, like many other companies, an unauthorized third party gained access to certain information maintained by Advance Auto Parts within Snowflake, our cloud storage and data warehousing vendor. We began an investigation to determine the nature and scope of the incident with the support of third-party experts and took measures to contain the incident and terminate the unauthorized access. Our investigation determined that an unauthorized third party accessed or copied certain information maintained by Advance Auto Parts from April 14, 2024 to May 24, 2024. We conducted a detailed review and analysis of the affected information to determine the types of information contained therein and to whom the information relates. This review was completed on June 10, 2024.

What Information Was Involved. The personal information about you involved in this incident may include your name and the following: Social Security number, driver’s license or other government issued identification number, and date of birth. This information was collected as part of the Advance Auto Parts job application process.

What We Are Doing. Upon learning of the incident, we promptly terminated the unauthorized access and took proactive measures aimed at preventing future unauthorized access. We also notified law enforcement. In addition, we continue to work with third-party cybersecurity experts to take steps to further harden our systems and emerge from this incident an even more secure organization.

As an added precaution, we are providing you with [Extra2 - CM Length] months of complimentary access to credit monitoring and identity restoration services through Experian. Although we are covering the cost of these services, you will need to complete the enrollment process yourself. Enrollment using the instructions can be found in the *Steps You Can Take to Help Protect Personal Information*.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors over the next twelve (12) to twenty-four (24) months. You can also enroll to receive the complimentary credit monitoring and identity restoration services that we are offering to you and review the information contained in the *Steps You Can Take to Help Protect Personal Information*.

- **Credit Monitoring:** Actively monitors Experian, Equifax and Transunion files for indicators of fraud.
- **Identity Restoration:** Identity Restoration specialists are immediately available to help you address credit and non-credit related fraud.
- **Experian IdentityWorks ExtendCARETM:** You receive the same high-level of Identity Restoration support even after your Experian IdentityWorks membership has expired.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General.
